In compliance with the Hon'ble High Court Order in WPA 5890 of 2020 dated 13 October 2020, in conjunction with the directives from the Rt. Rev. Dr. Paritosh Canning, Bishop of Calcutta, Chairman, Board of Governors, Pratt Memorial School you are hereby informed that:

In view of the Global Pandemic of COVID-19 -

There is no increase in fees during the financial year 2020-2021.

There will be 20% reduction towards Tuition Fees and Session Fees for the period April 2020 to the month following the one in which schools reopen in physical mode.


No fee will be charged towards unused facilities such as Library, Computer, Laboratory, Sports & Games.

Those parents/guardians who are able to pay the full fees are kindly requested to do the same.

All fees payable for the period up to November 2020 should be remitted latest by 30th November 2020. If fees are not paid students may be disallowed from attending classes with effect 08th December 2020 as per the given order of the Hon'ble High Court.

No student can apply for a Transfer Certificate without clearing all the fees payable.

NOTE : The said fees structure ie. 80:20, shall be subject to the Final Outcome of the SLP Diary No. 22940/2020 (La Martinere Boys School and ors Vs. Vineet Ruia and ors) pending before the Hon'ble Supreme Court. Any modification of the 80:20 fees structure (as prescribed by the High Court) by the Hon'ble Supreme Court in the aforementioned SLP, would ipso-facto mean that the guardian/parents will have to deposit the deficit fees in due course.
